- There shall be an exchange of students/faculty members for training purpose.
- The duration of exchange visits will be determined by the Mutual consent between Both the parties.
- Both parties shall provide certificates of the training for all training programs (Conduct, if any) to successful participants. Both parties shall seek feedback from each participant of training program (if conducted) about overall quality program resource person's etc.
- The registration fee for training program/charges against availing Instrumentation facilities for sample analysis shall be decided and determined by Mutual consents between both the parties.
- Both parties shall provide all necessary infrastructural facilities such as Classroom with projection facility, laptop and internet connection to resource person during training program.
- It is responsibility of the individual from both the parties from any breakage or damage to any equipment or instruments during analysis in the respective Laboratories.
- The MoU may be terminated at any time during the currency of its period of Validity through mutual consent after 30 days, notice from whether side in this Regard.
