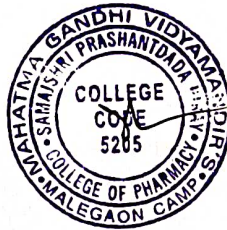

4. Kindly provide Internship completion certificate / project work completion certificate from the organization where internship / project work was completed with duration for all the students who participates.

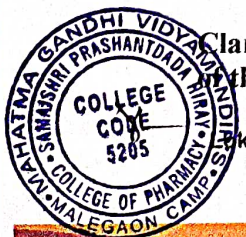

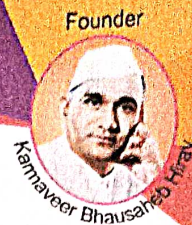

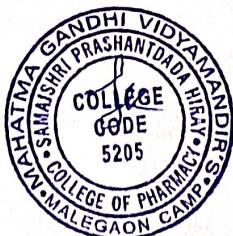
