- Both Parties Mahatma Gandhi Vidyamandir's Samajshri Prashantidada Hiray College of Pharmacy ( B. Pharmacy and D. Pharmacy) , Malegaon Camp (First Party)and Late Dr. G. M. Bhavsar Charitable Trust's MALEGAON BLOOD BANK , Malegaon ( Nashik ) (Second Party) will provide their students /staff / other laboratory facilities / training / academic / research and analytical services / environmental awareness / API samples / environmental awareness / safety / social services / health support and similarly any other services for the successful completion of the different educational and research activities.


2. All collaborative activities will fully be knowledge and endeavor based by both the parties.
3. The parties will evolve a mechanism for exchange of experiences and expertise for mutual benefits of graduates and the college.
4. The expenses incurred on any activity will be borne by the first partner. The other partner will be immune from any such financial liability. In case it will be mutually decided.
5. Any other point which is not covered under this MoU but may be mutually beneficial and agreed upon for both the parties.
6. This MoU Shall be construed as a purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall create any legal relationship between the parties.
7. This agreement will take effect from the date of its signing and shall be valid for a period of Five years. However, the agreement may be terminated before the expiry of the period of Five years by six months' notice in writing delivered by any party to the other.
8. The Parties are hereby agreed to establish mutual association on aforesaid areas.
