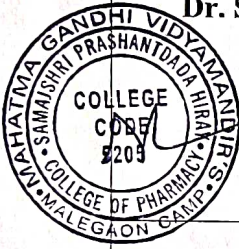
The both Parties after due considerations of various aspects have arrived at the following understanding in respect of dissemination of academic knowledge, participation in various educational programmes:-

7. This agreement will take effect from the date of its signing and shall be valid for a period of **Five** years. However, the agreement may be terminated before the expiry of the period of **Five** years by sixth months' notice in writing delivered by any party to the other.
8. The Parties are hereby agreed to establish mutual association on aforesaid areas.

## Activity Report of MoU

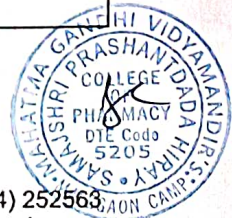
**(Sai Sanjeevani Naturopathy and Paralysis Research Centre, Malegaon, Dist. Nasik (MS))**
