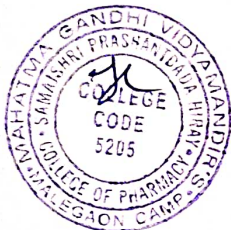

- (c) Employ any of the moneys, goods or effects of the limited liability partnership or pledge the credit thereof, except, in the ordinary course of business and upon the account or for the benefit of the LLP Firm.
- (d) Give any security or promise for payment of money on account of the LLP Firm, except in the ordinary course of business.
- (e) Enter into bond or become bail or surety with or for any person or do or knowingly cause or suffer to be done anything whereby the said business of the LLP Firm or its property or any part thereof may be seized or taken in execution or otherwise become liable;
- (f) Assign, mortgage or charge his share in the LLP Firm or any part thereof or create a charge on the LLP Firm assets or make any other person a Partner or sub-Partner with him;
- (g) Forgive the whole or any part of any debt;
- (h) Compromise or relinquish any claim or portion of a claim of the firm;
- (i) Enter into a Partnership on behalf of the LLP Firm;
- (j) Refer to arbitration any dispute in which the LLP Firm is concerned with the third party whether or not a suit in court



has been instituted for the same or admit any liability in a suit or proceedings against the LLP Firm.

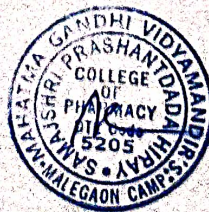
