4. Project Norms -

All the trainees should belong to prescribed district as per target.

The Training Partner will establish a fully equipped Training Centre at the given location as per the norms of Skill India portal for the respective job role. The Training must have bio-metric system for capture real time attendance of trainee and trainer. Access of biometric will be shared with LSSSDC for inspection at any point of time of the training course.

- To mobilize the candidates, the TP will publish an informative advertisement about the program.
- TP will upload the candidates on Skill India portal.
- The list of shortlisted candidates, Certificate of successfully approved center and a day wise Activity cum Lesson planner (ACLP) should be submitted to LSSSDC.
- TP will maintain a separate file for each batch consisting details of enrolled candidates and trainer.
- The TP will have to recruit trainers as per the eligibility criteria of LSSSDC and send them for Training of Trainers.
- The certified trainers will only be allowed to take classes.
- The training may be imparted to persons of target group who are of 18 Years and above on date of completion of assessment / certification.
- After training, the candidates will be assessed by LSSSDC certified Assessment Agency.
- The TP will have to place minimum 70% successfully passed candidates. The TP will submit receipts of proof of placements of minimum 70% of the trainces in wage / self-employment with Self-declaration from the trainces mentioning the 3 month placement retention offered by TP Along with Appointment letter + Salary slip, PF Slip / Bank statement (For wage employment) or Copy of registration of firm / shop / factory / Copy of GST registration /bank sanction of business loan / Work site / shop / factory photographs (For Self-Employment), Trainces Placement details.
